Minutes:

- 1. A quorum was present (9 members were present)
- 2. Carmel construction on the site of the former Marriott Hotel
 - a. Carmel stated that they have obtained all required permits
 - b. Building A (near Woodley Tower) will have concrete complete/top out in July, finish in 2025.
 - c. Building B (on Calvert) it will top out in October 2024, finish by 2026.
 - Asked about the sink holes, Ronnie Gibbons of Carmel said that some (mostly around the park) were there since 2021, before Carmel took possession. Carmel is studying their cause. They've roped them off, marked them, and warned local schools of the danger.
 - e. Average unit size in building A is 1,100 square feet 38% 1BR, 44% 2BR and 18% 3BR. 290 units in total.
 - In building B the average is about 800 square feet, with 34% efficiency units, 35% 1BR, 32% 2BR total of 577 units
 - g. There are no DHS-defined hazardous chemicals on-site.
 - h. There is some intermittent jackhammering to remove rock in footing of B building basement. Carmel has tried to drill, rather than pile drive in order to reduce noise. The

jackhammering should be completed by the end of this month. There will be some noise (likely less) from constructing the building until October.

- i. A neighbor noted that work for the construction seems to have occurred after 7PM. Carmel said loud noises may only be produced between 7AM and 7PM. Other non-noisy activities can take place from 6AM to 10PM (e.g., to get deliveries, staging, safety meetings, etc. After 7PM the concrete batch plant is cleaned, and there may also be some concrete finishing work after 7PM.
- j. Nicholas DellaDonne indicated that an appeal has been filed by Wardman Vision with the Board of Zoning Adjustments seeking revoke two Carmel building permits. Interested parties can contact him at WardmanVision
- k. There will be 883 parking spaces provided more than one per unit (more than required by City zoning – which is approximately 300 spaces). They will be rented separately from the residential units. No decision yet on whether there will be visitor spaces.
- I. All of the units will be rental apartments (not condominiums)
- m. Carmel does not have a charitable foundation, but as projects reach completion, it often does make some sort of contribution
- n. Adam Prinzo offered to accept input from his ANC district, which includes the Carmel site
- 3. Financial stuff
 - a. Treasurer's report was accepted
 - b. Annual review of books will be done by Danielle Leone and Nico Ojeda
 - c. Budget and big ticket items for 2024 shred day, picnic, and holiday party (we could ask Carmel to contribute by sponsoring our holiday party through 2035, for example)
 - d. For the holiday party, we paid Lillie's \$2,400; received \$121 via Square, \$560 in cash (\$80 from attendees, plus \$80 in membership contributions). Every attendee contributed the \$10 requested, except maybe 2.
- 4. The grocery garbage enclosure should be on the Public Space Committee's agenda for their January meeting. Adam Prinzo shared an artist's rendering, which showed the enclosure extending 4 feet out from the building, and 29 feet from the building entrance awning, which falls short of abutting Elsa's Restaurant. A question was raised to ask Adam to see if he can identify the building material that is planned to be used. (i.e., will it be steel to keep rats out?)
- 5. Zach Messitte will schedule a meeting with the Ambassador from Benin when he returns in late January to present a proposal for Benin-US friendship park in the vacant lot that was formerly the site of the Benin Chancery from 1960 to 2007. Zach estimates that refurbishment/prep of the site to serve as a park, dog walking area, possible community garden, could be accomplished for about \$50k but that Benin is unlikely to pay. Potential other funding sources are being identified.
- 6. Boundaries for Oyster & Eaton elementary schools several WPCA Executive Committee Members expressed opposition to the proposed change in attendance boundaries for Oyster that affect Woodley Park residents but wanted more information about how many families/kids would be affected. Janell Pagats will work to create a task force to consider and provide input/advocacy on the school boundary issue
- 7. Morning drop off at Aidan Montessori school has become chaotic. Cars back up on 27th Street, wait for drop-off blocking the street. Parents exit their cars to walk their kids into school. Aidan's community is perceived not to be following the school's traffic management plan agreed to by the ANC, the Woodley park Community and Aidan.
